II. TERMS OF BOOKING & PAYMENT

- a. Pencil-booking Free Pencil-Booking valid for 15 consecutive days.
- b. **RESERVATION FEE (RF)** It is the confirmation for a pencil booked date amounting to 50% of the total venue rental fee which is consumable but non-refundable. Signing of CLIENT AGREEMENT is made upon payment.
- c. **50% FULL PAYMENT** It must be settled a month before the event date.
- d. **SECURITY CASH BOND** It is required from all clients for the safety and security of the tent and its amenities amounting to Twenty Thousand Pesos (Php 20,000.00) which will be refunded upon release of clearance from the management. Payment is made a month before the event together with the Full Payment.

Note:

- 1. Client must confirm the booking Three (3) months before the event date; otherwise, RESERVATION will be considered void.
- 2. Metrotent will provide STATEMENT OF ACCOUNT for BUDGET REQUISITION PURPOSES.

III. CANCELLATIONS

Metrotent conducts weekly updates for pencil-booked/reserved events. Thus, Metrotent reserves the right to cancel bookings/reservations based on the following:

a. If Metrotent would not receive feedback within 24 hours from the time Metrotent sends a message through phone or email. Since the client is unreachable, Metrotent cannot afford to extend bookings/reservations since there are others who are already willing to pay for the slot.

b. If Client already settled the Reservation fee but fails to pay the 50% Full payment a month before the event.

c. If the Client cancels the event, Client must provide their cancellation request to Metrotent in writing. If cancellation is made on the following:

- a. Three (3) months before the event, the initial deposit is non-refundable and shall be forfeited.
- b. Within a month prior to the event date, fifty percent (50%) of the remaining full payment will be collected.

c. Any re-scheduled date will require a New Rental Agreement.

d. If cancellation is due to Acts of God, 100% of total rental fee will be refunded to the client.

USAGE

- a. Only the tent space, air-condition, and house lights are included in the rental package. There will be no usage of space outside of tent as an activity area unless permitted by the management with the corresponding charges. Chairs, tables, stage and sound systems are not included.
- b. If the Client needs additional requirement such as carpets, drapings and other decorations, the amount/cost will be shouldered by the client.
- c. Time of 8-hour usage will be formally consumed once the generator starts to function and shall end not exceeding 1:00am.
- d. Client must bring in their own generator for additional electric consumption for sounds, lights, LED, etc.
